Dear Student, US Sponsor, Sponsor Organization, and Bank,

The tuition package rate for the College of Undergraduate Studies (Traditional) program at Colorado Christian University per year is \$22,610 (this covers 12-17 credits). Other costs might include student fees (\$350), room & board costs (\$9,840), health insurance, and other fees (estimated at \$1,200). Books can also cost up to \$1,000 per year. Similarly, international students should understand that they are not allowed to work for the first year at Colorado Christian University (except on campus) per F1 Visa regulations, and should, therefore, plan to bring spending money with them.

Thus, Traditional international students need to certify (per I-20) that they have access to \$35,000.00 USD for each year of study at Colorado Christian University (minus scholarships) by providing verification of one or more of the following:

- (1) Provide official documentation from a sponsoring American citizen guaranteeing coverage of expenses [see DHS I-134 government form]; or use verification of funds form
- (2) Provide a personal bank statement showing adequate family funding for one year using the verification of funds form
- (3) Provide official documentation from a sponsoring organization guaranteeing coverage of expenses using the verification of funds form
